SPECIFIC CAVY DEPARTMENT RULES & REGULATIONS

1. The rules printed herein, and the Poultry Building General Rules are made a part of the conditions under which all entries of exhibitors are made, and exhibitors are respectfully requested to read them carefully, thereby avoiding confusion at the time of the Fair and to ensure they are entering their exhibit correctly.
2. Due to space limitations, there may be a cap on Cavy entries. Entries over the limit will be subject to restrictions at the discretion of the Superintendent. (No additional passes will be given for entries over 12 animals.)
3. Animal health regulations listed must be complied with, as well as all general regulations of the Poultry Building in separate file. All entries are subject to general rules and Animal health regulations listed in the poultry building general rules.
4. The Fair reserves the right to add or substitute judges if conditions warrant.
5. The greatest possible care will be given to all exhibits, but the Management will not be responsible for any accident, mistake, loss or damage that occurs. Specimens are entered at the sole risk of the owner. Competent personnel will be in attendance and the Management will do all in its power to ensure the safety and protection of the exhibits. Each specimen must be the bona fide property of the exhibitor.
6. At check-in, all cavies must meet the minimum weight requirement, as set forth by the ARBA standard. Any diseased or injured animal will be rejected and sent home at the discretion of Management.
7. Cavies must be checked in by Fair Staff and pass a health check before being placed in a coop.
8. Cavies must have an approved ear tag in the left ear. This is an ARBA Rule. Any animal not permanently marked will be rejected.
9. 4-H'ers must let the Superintendent know which cavies will be shown in the 4-H Show. This includes animals used for the Decathlon event.
10. Animals entered into the show may be sold only if the animals are judged but cannot leave the building until exhibits are released or by permission of the Superintendent. Please pick up a statement of additional rules regarding sales upon check-in.
11. Exhibitors may not place any signs on any coop or display. Exhibitors wishing to sell cavies must provide a legible list to the Superintendent, containing Exhibitor name, phone number, coop number and sale price. Only the Superintendent or appointed State Fair Staff shall maintain the sales board and process sales. Exhibitors may NOT alter the sale boards or conduct sales on behalf of the Fair, NYS Old Timer's Club or themselves. Should you violate this rule, you will NOT be allowed to sell animals for one year.
12. No exhibitors are allowed to enter the building outside of the posted public building hours unless an appointment is made with the Cavy Superintendent.
13. Express shipments will not be accepted. Any animal entered into the show and placed for sale cannot be sold from home or directly through exchange between the exhibitor and buyer. All sales must have an official receipt from the Superintendent or a designated State Fair Staff member. Should you violate this rule, you will NOT be allowed to sell animals for one year.
14. Ribbons and specials must be picked up on closing day.

15. To compete for display prizes, exhibitors must exhibit at least ten single entries.
16. Specials received too late for publication in the Premium Book will be posted in the showroom. Specials offered by individuals or clubs will not be guaranteed by New York State Fair, but all are believed to be bona fide offers.

Division AA – SPECIAL AWARDS

Every effort has been made in compiling our rules and regulations to conform to the association standards as furnished. However, in any possible discrepancy that may develop, State Fair Rules will apply. This is an **Official New York State Rabbit and Cavy Breeders Assoc. Sweepstake Show**. Points to count for NY Sweepstake Awards. In order to compete in fur classes each animal must be entered in regular competition. Same entry fee and prizes as in regular breed classes.

All points count as follows: First=6; Second=4; Third=3; Fourth=2; Fifth=1; multiplied by the number of specimens shown in each class.

Department #18 – CAVIES

Juniors up to 4 months of age, minimum weight 12 ounces, maximum 22 ounces. Intermediates up to 6 months of age or weight over 22 ounces and up to and including 32 ounces. Seniors over 32 ounces.
